## **Compliance with Food Procurement Requirements for Nursing Homes with Gardens Producing Foods for Residents**



CMS and the Food and Drug Administration (FDA) have received inquiries from nursing homes and State survey agencies asking if Federal law permits nursing homes to have produce gardens and use the foods harvested on the menu for any portion of the resident population. The facility should be following safe food handling practices once foods are harvested and brought to the kitchen for preparation.

### Raising Expectations: A State Scorecard on Long-Term Services and Supports for Older Adults, People with Physical Disabilities and Family Caregivers

This State Long-Term Services and Supports (LTSS) Scorecard is the first of its kind: a multidimensional approach to measure state-level performance of LTSS systems that provide assistance to older people and adults with disabilities. Performance varies tremendously across the states. The Scorecard examines state performance across four key dimensions of LTSS system performance: (1) affordability and access; (2) choice of setting and provider; (3) quality of life and quality of care; and (4) support for family caregivers.
